## **Service Academy Congressional Nomination Application Procedure**

#### 1. Preliminary Requirements

- a. Verify that all requirements of the academies have been met, which are as follows:
  - i. Must be unmarried, not pregnant, and have no legal obligation for a child or other dependents.
  - ii. Must be a United States citizen.
  - iii. Must be at least 17 years old and not have reached your 23rd birthday
- b. The applicant must be a legal resident of the Fourth Congressional District. Military families or anyone with questions about their residency should call the Richmond Office at 804-486-1840
- c. The applicant should write to their congressional offices at the end of their junior year of high school, expressing his or her interest in attending a service academy.
- d. It is the responsibility of each applicant to initiate a pre-candidate file at each academy to which they are seeking a nomination.

### 2. Application Form

- a. Complete all sections.
- b. Sign and date Section VII.
- c. Verify that you meet all requirements of the Nomination Process, which are as follows.

#### 3. Letters of Recommendation (3)

- a. Ask your high school counselor, a teacher, or principal to provide a letter of recommendation. Include two additional letters of recommendation from teachers, coaches, employers, or someone who knows you well.
- b. Have all three individuals send the letter to you in a sealed envelope with their signature across the seal.
- c. Or email the letters directly to John Montgomery: <u>John.montgomery@mail.house.gov</u>





#### 4. Transcript

- a. Ask your counselor or principal to provide you a copy of your school transcript.
- b. Make sure the transcript includes:
  - i. Your course listings and grades through the end of your junior year
  - ii. Current Grade Point Average
  - iii. Class rank (if provided by your high school)
  - iv. SAT/ACT scores (if provided by your high school)
- c. The official transcript should be returned to you in a sealed envelope with a signature across the seal.

#### 5. Standardized Test Results

- a. We recommend that you take the SAT or ACT as soon as possible.
- b. Since many transcripts include standardized test scores, you do not need to send official scores from the testing center, i.e. SAT and ACT.

#### 6. Essay

- a. On a separate sheet of paper, please compose an essay on why you want to attend a U.S. Service Academy.
- b. Make sure it is approximately 300 words and entitled, "Why I Want to Attend a United States Service Academy."

#### 7. Additional Attachments

- a. tasteful and recent photograph of yourself
- b. College transcripts, if applicable
- c. Optional resume of your accomplishments and activities
